Prize Description:

The raffle prize representing this ticket is a 2002 medium size “Market Basket” with large fabric liner in the “Old Glory” pattern, and plastic protector, handmade by The Longaberger Basket Company, Dresden, Ohio. The bottom side of the basket has been hand initialed by the weaver with the inscription “VCCI 2002”. In addition, 12 Longaberger family members have added their signatures with the following inscriptions: “Wendy Longaberger 2”; “Jerry Longaberger 3”; “Larry Longaberger 4”; “Tami Longaberger 2003”; “Rachel Longaberger 2003”; “Rich Longaberger 6”; “Mary Longaberger 7”; “Judy Longaberger 8”; “Ginny Longaberger 9”; “Gary Longaberger 10”; “Carmen Longaberger 11”; Jeff Longaberger 12”. No other defining markings are recognized.

Winner will be notified by use of the telephone number provided on the ticket stub at the time of purchase. Odds of winning are not greater than 1:1000.
